### Phi Sigs - Delta Chapter - The Fourth House

Due to several unforeseen circumstances, specifically this editor breaking his leg in February while skiing and also a major EIU archives "snafu" with the microfilm of old Eastern newspapers, my research for this House will not be as extensive as it could be. I will endeavor to bring you the "rest of the story" or at least important developments in the Fall '95 PSE Newsletter.

I did recently receive several old EIU newspapers from a local auction, one of which was dated Wednesday, Sept. 21, 1938, featuring an article titled "Phi Sig Alumni Purchase Large Residence on Ninth." The byline states that "Actives spend opening week remodeling, redecorating new 16-room domain", and as you can discern from the present picture of this house, it is a very large, well-cared-for house. The article states that "Headed by Leallyn Clapp and Hugh Harwood, the Alumni Association Inc. of Phi Sigma Epsilon fraternity last month purchased a large 16room house, including dormitory, at 1431 Ninth Street in Charleston, which now houses 20 active members." It goes on further to inform that "For the last two weeks carpenters and members have been remodeling and redecorating the whole interior of the house. It now boasts three living rooms downstairs, seven second-floor study rooms, and a modern shower room in the basement. The dormitory on the third floor provides sleeping quarters for the whole house. In the near future those in charge plan to buy a new overstuffed suite for the downstairs, and shortly thereafter the house will be thrown open for inspection by the whole school.

Reflecting back to the Fall '94 Newsletter to tie in the purchase of this House with the previous rental of houses, you may recall that they were in Sept. 1937, obliged to accept a 1-year lease on the Fourth St. PSE House after having had their Seventh St. PSE House sold out from under them in May 1937. Knowing that, the Alumni Assn. of 1937-38 had time to seek a residence that would fulfill their growing needs and that residence is the feature of this article. The dining service that was started in 1936 did continue through the 2 moving transitions to the 1431 Ninth St. residence. The same aforementioned Teachers College News article states "James Rice, quartermaster, reports that the Phi Sig dining service is now in full swing, accommodating 34 fellows. 'We have two new electric ranges and an electric stove,' he states. Emmett Shipley, '40, and Evon Higgins, '40, are chief cooks."

We must now necessarily proceed from 1938 past the "snafu"

at EIU with no Eastern newspapers for information, and stop right around the early fifties, near the end of the Ninth St. House and the beginning of our last House, located at 1509 Second St. More

about that House in the Fall '95 Newsletter.

John Simmons ('53 - "The Toe") graciously provided the last bits of history that we have for 1431 Ninth St., when he wrote this editor about his recollections of the time. He relates "Now about our chapter. We consistently swept about 3/4 of class offices. We



made it a point to select outstanding men from all departments across the campus. Then we would campaign for our men throughout those departments for class offices. This is what was amazing." It is now clear why there were always Phi Sigs serving as class officers, as noted in many of the old EIU Warbler yearbooks. I'll bet we would like to be paying the expenses of the early 50's in our own time too, although they were probably similarly relative to the pay of the day. As John remembers them, it cost \$6.00 per week to live at the House (\$216.00/year), plus an additional \$162.00 per year for food, which included your own cooking, buying, serving and cleaning up. Fraternity dues were \$36.00 per year and just for comparison sake to now, tuition was \$105.00 per year. To conclude, John recalls "I believe we had approximately 20 guys in the House and we slept in an upstairs dorm. We had meetings, parties, pledge smokers, pledge initiations, food service, played poker and pinochle, sponsored the Crystal Ball at the college, and what I remember most was the bull sessions we had about every night from 10:00 to 11:00 p.m. We had an outstanding group of men and belonging was a real learning experience."

From my personal perspective of a different time, not much has changed from what John experienced, except we had no food service or Crystal Ball, and of course, things were a bit more expensive. If you have any interesting stories about life at 1431 Ninth St. or more especially next Fall's feature House at 1509 Second St., let us know at the PSE Alumni Assn., so they can be

Although the upstairs area in Eddy's Lounge was being remodeled into an upper bar area, we did have the area to ourselves, which facilitated a free flow of cheap talk and stories

#### FIFTH ANNUAL STUDENT AWARDS

This monetary grant is free of all payback and has no provisions as to how it must be used. Additionally, it is restricted by age to those 25 or younger and the PSE Board also reserves the right to make discretionary exceptions to the above-noted guidelines on a case-by-case basis.
