ELEVENTH ANNUAL STUDENT AWARDS

It hardly seems possible that 10 years have gone by already since the inception of the PSE Alumni Assn. Student Awards in 1991, but this year's Awards will mark the ELEVENTH year that we have given financial assistance.

As you may well know by now, the Phi Sigma Epsilon Alumni Association has embarked on an annual Student Awards program to financially assist identified children of former Phi Sigs (P.S.E., that is), Delta Chapter at Eastern Illinois University. The Association has been able to award grants totalling over \$30,000 the past 10 years.

With the receipt of this Newsletter, eligibility is open for you to submit to the P.S.E. Alumni Association, the names of children who will be attending EIU in Fall 2001 or those already in school as full-time undergraduates.

The cutoff date for submission of the Student Award Information questionnaire form in this Newsletter is August 10, 2001. Upon receipt and verification of children attending or about to attend EIU, notification will be forwarded to you regarding the Student Award. These awards will be presented on Sunday, August 19, 2001 in Charleston. Only one monetary award will be granted per family. This monetary grant is free of all payback and has no provisions as to how it must be used. Additionally, it is restricted by age to those 25 or younger and the PSE Board also reserves the right to make discretionary exceptions to the above-noted guidelines on a case-by-case basis.

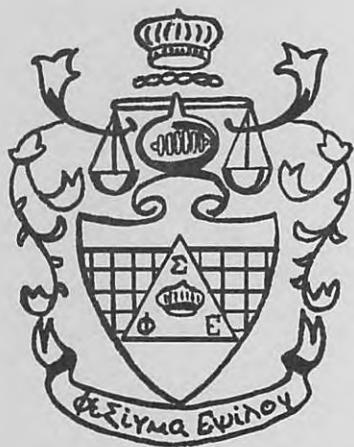

The Case of the Missing Newsletter!

Some of you may have noted that there was no Fall, 2001 newsletter. There is a simple explanation – Money (or lack of money).

Many of you are probably not familiar with the operation of the PSE Alumni Association. Our funding is derived entirely from the proceeds of the sale of the house. That dollar amount was \$60,000. The directors have made a concerted effort to not touch the principal amount, operating the Association on the interest generated from the principal. Our reasoning is based upon the fact that once we start tapping the principal, it is the beginning of the end for the Association. Once the principal is gone, there would be no more money to operate and we would go the way of the dinosaur.

Up to now, while our budget has been tight, we have been able to generate sufficient operating income. Everyone has seen what has happened to interest rates and we have been profoundly affected by the lower rates. But for the fact that we locked in higher rates on some CD's, we would be in terrible shape. We have had to adjust our very conservative risk toler-

ance on our investments and have invested a portion of the money in a somewhat riskier, yet still fairly conservative portfolio, in hopes of generating additional income and allowing us to continue with the programs we have started. At the February 2002 directors meeting, we determined that we would be able to meet our fiscal goals for 2002. Beyond this year, the prospects are not bright.

As an organization we have made a concerted effort to not engage in the "begathons" which have become so prevalent, including the annual EIU fund raising programs. However, we are now at the point where we need to go to our constituency and ask for assistance. Do you support us in our efforts to keep the association alive, distribute periodic newsletters and provide student awards? If so, give us your thoughts about what we can do to keep things going. More importantly, if you can, provide us with whatever financial support you can. Send your comments and/or contributions to the address shown on this newsletter or feel free to contact any of the officers or directors.

Hall of Fame Inductees

Gene Everett ('72) and Larry Kanke ('68) were both inducted into the Illinois Wrestling Coaches & Officials Association Hall of Fame at their banquet held in Darien, IL on April 27, 2002. Gene was an assistant coach at several schools before becoming the head wrestling coach in Gibson City in 1975. He took a 3-year sabbatical between 1994 and 1997 to work on an advanced degree and then resumed the position of head coach at Gibson City/Melvin/Sibley HS in 1997. He will retire from his coaching duties at the end of the current school year with a career coaching record of 271-195-5. His teams have won 5 conference titles in only 10 years, in a conference that had only offered a championship tournament in the last 10 years. Overall,

Gene has had 33 state qualifiers, 8 state medalists and one state champion.

Larry began coaching and teaching at J. D. Darnell HS in Geneseo, IL after getting out of the U.S. Army in 1970. His

teams have had a dual record of 393-201-4 and have won 11 NCIC Conference Championships and 5 Regional titles. He has had 66 state qualifiers and 12 state placemen, including sons Tim and Mike, who both placed twice at the state tournament. Larry has also been an IHSA wrestling official for 27 years and an official for USA Wrestling in both Freestyle and Greco-Roman. He will retire from teaching and coaching at the end of the current school year. Congratulations to both Gene and Larry!

PSE Eleventh Annual Student Awards

Sunday, August 19, 2001, dawned as a beautiful day for the presentation of monetary awards to five EIU students, whose fathers were Phi Sigs at Eastern. On this day, the PSE Alumni Association began its second decade of providing monetary assistance to those students meeting our criteria. To date, we have provided over \$33,000 of aid to students, and since the first group in 1991 received the first of many checks, there have been 28 different students from over the years that have benefited.

They were Sara Kasperski, daughter of Pete and Debbie Kasperski of Spring Valley, Illinois and Chris Swing, son of Dick Swing of Cissna Park, Illinois.

As has been the custom of the past, we asked the Phi Sig parent to update his family ongoing since the days of EIU and then asked the Awards recipients to also give us some insight into their studies and what they project as their future endeavor in the workplace. As might be expected from them in an environment of "being the new kid on the block", they were rather shy about their futures and themselves. Several students over the years however, took advantage of the outreach of help-when-needed extended by the PSE Alumni Assn. local officers and sought our assistance or guidance above and beyond the mone-

tary Awards they received. It is gratifying to be accorded the honor of their trust while at school and away from home. After the formal part of the presentations were over, and having had our catered picnic lunch, the informal gathering visited for awhile preceding the inevitable need to travel home or move on to other activities. Last of the First

On February 10, 2001, the Phi Sigma Epsilon Alumni Assn. lost an alumnus of sorts, with the death of probably the last surviving member of the group Delta Lambda Sigma, that was formed in 1928 at Eastern. That group was the predecessor to Phi Sigma Epsilon, which became the first organized fraternity at Eastern in 1930. Andrew E. Meurlot died of heart failure at the age of 95 in Decatur, Illinois, after a short convalescence following a fall-related hip injury and resulting surgery.

After graduating from what was then Eastern Illinois State Teachers College in 1929, Andrew began his teaching career in a number of local small schools, where, as his son Karl related to me, he was both the teacher and in some instances, the principal or administrator. In those earlier days, there was not the requirement for a specific administrative degree to be in that position of authority, especially in smaller towns such as Humboldt, Neoga and Scotland (IL - near Danville). In the latter community, he befriended a man named Tucker, whose grandson Otho Tucker is probably remembered as a star basketball player at the University of Illinois.

In 1945, Andrew took his teaching career and family to Decatur, IL. to begin and ultimately end his career in 1971, after 42 years of teaching. He was also a part-time instructor at Richland Community College, the local junior college in Decatur, IL.

In high school, he was a standout basketball, football and track athlete, and continued his athletic skills at Eastern in basketball and baseball. Always being the consummate lover of athletics, he was not only a teacher, but a coach on many levels in high school, even being asked to be the tennis coach for one year until a coach could be hired. After having had to be shown how to hold the racket initially, he guided that team from Decatur McArthur H.S., to a second-place finish in the state tournament. He also became very active in officiating high school basketball and football games, continuing those activities until his retirement, and ultimately being elected to the IHSA Hall of Fame. After retirement, he took up the game of golf with a passion, continuing to play it until the year before his death, when sadly, his eyesight robbed him of the pleasure. He also enjoyed competitive softball in the area and played with the likes of one of our area standouts, Merv Baker. He never missed any of the E.I.U. Hall of Fame football games for as long as they were organized.

Although never being formally initiated as a member of Phi Sigma Epsilon fraternity, he sounds like he was probably one of the original molds for membership.

Andrew is survived by a son Karl, in Decatur, IL. and a daughter Carol, in Seneca, SC, who is in real-life, married to EIU graduate and Phi Sig alumni, Kenneth R. Vick ('58), a retired high school principal from Springfield, IL.
